- ii. *Preferences:* Persistent cookies remember your choices, such as password storage and website/mobile application session persistence.
- iii. *Analytics:* Cookies analyze your website/mobile application usage, including pages viewed and visit duration, to enhance our services.
- iv. *Advertising Technology:* We may use cookies to present tailored advertisements based on your previous visits.
- v. *Google Analytics:* Utilized for web analysis, Google Analytics cookies provide statistical information/reports on website/mobile application usage.

c. Cookie Management:

- i. *Google Chrome:* Manage cookies in the "Cookies" tab by clicking the "lock" sign in the URL section.
- ii. *Internet Explorer:* Control cookies by selecting "allow" or "do not allow" in the security tab.

iii. *Mozilla Firefox*: Manage cookies through the "Options" icon and "Privacy and Security" button.

iv. *Opera*: Control cookies in the "Cookies" section under "Advanced" in the "Preferences" menu.

v. *Safari*: Manage all cookies in the "Privacy and Security" section under the "Safari" tab in your phone's settings.
